Master of Professional Studies Requirements for Graduation

- Students must complete at least 30 semester hours (sh) of coursework that apply to their Rowan University degree.
- Students must have a cumulative GPA of at least 3.00 in Rowan University coursework. (Transfer courses/credit do not count toward the RU GPA.)

The Master of Professional Studies (M.P.S.) with the Certificate of Graduate Study (COGS) in Corporate Entrepreneurship will provide students with organizational leadership and analytical skills coupled with the strategic planning and entrepreneurial cultivation proficiency that can change a wide variety of industries. The program is comprised of the MPS core curriculum in project and agile management, teambuilding and analytics complimented with a specialized focus on driving innovation and fostering entrepreneurship in a corporate setting by applying the 9 credit COGS in Corporate Entrepreneurship. Studies are finalized with an application of skills in an action study course. Students who graduate from this program will be prepared to move forward within their field by demonstrating indepth analytical competencies, leadership skills, and effectively nurture opportunities for new growth.
